BY SIGNING THIS AGREEMENT YOU ARE GIVING UP CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO RECOVER DAMAGE IN CASE OF INJURY, DEATH OR PROPERTY DAMAGE, ARISING OUT OF YOUR RIDING OR USE OF ABOVE HORSE(S) AND/OR PARTICIPATION AT ELECTRIC EQUINE LLC. THIS INCLUDES ALL INJURY, DEATH, OR PROPERTY DAMAGE ARISING OUT OF THE NEGLIGENCE OF YOU OR ELECTRIC EQUINE LLC AND ITS REPRESENTATIVES.

READ THIS AGREEMENT CAREFULLY BEFORE SIGNING. YOUR SIGNATURE INDICATES YOUR UNDERSTANDING OF AND AGREEMENT TO ITS TERMS AND CONDITIONS.

Code of Montana §27-1-725 states: "An equine activity sponsor or an equine professional is not liable for an injury to or the death of a participant engaged in an equine activity resulting from risks inherent in equine activities."

**EQUINE RELEASE AND WAIVER OF LIABILITY,  
ASSUMPTION OF RISK, AND INDEMNITY AGREEMENT**

Definitions: The term “**Electric Equine LLC**” shall herein refer to Tanner Whitlock, Kaitlyn Whitlock and/or other Electric Equine LLC representatives, associates, principals or agents. The term “**Electric Equine LLC Facilities**” shall herein refer to land or property owned, leases or managed by Electric Equine LLC or Tanner Whitlock.

By signing this form, I hereby acknowledge on behalf of myself that I have familiarized myself with the activities that I will be allowed to participate in, and that I do hereby acknowledge and agree that I will participate in these activities without restriction or limitation. I recognize the inherent risks involve in riding and working with horses, including but not limited to:

- Bites, kicks, abrasions or contusions from horses.
- Being thrown, or bucked off from horses.
- Scratches or other injury from stalls, enclosures, or other facility equipment.
- Scratches or other injury from grooming tools and other equine equipment and tack
- Allergic reactions to animals, hay or other allergens on the premises.
- Tripping on holes or on materials or other equipment on the premises.
- Slipping, falling, or otherwise being injured in the barn, paddocks, stalls, parking area or on the grounds, which can be slippery, muddy, wet or contain or present other hazards.

I hereby specifically forever waive and release Electric Equine LLC from any liability for injury arising out of the inherent risks from riding, working with, and being present in a stable environment and/or with horses. I specifically forever waive and release Electric Equine LLC from any liability from the active negligence of myself or Electric Equine LLC. I understand that I am present at Electric Equine LLC Facilities at my own risk.

By signing this agreement I hereby acknowledge that although there may be supervision during my time spent at Electric Equine LLC Facilities, there will not be a nurse on the premises and Electric Equine LLC shall bear no responsibility for my health or medical care.

I agree to indemnify, save and hold harmless Electric Equine LLC from and against any loss, liability, damage, attorneys’ fees, or costs that they may incur arising out of or in any way connected with either my presence or participation at Electric Equine LLC facilities or any acts or omissions of Electric Equine LLC.

By signing and initialing this agreement, I hereby acknowledge my complete understanding, agreement and consent to my presence and or participation in activities at Electric Equine LLC Facilities, without restriction, without liability to Electric Equine LLC, and with full knowledge and understanding of the disclosures, waivers, and release herein.
